Nominator Packet for the XI<sup>th</sup> Bishop of Springfield

## **Who can nominate?**

1. Each nomination requires sponsorship from one lay person and one clergy person.

Any lay member in good standing in The Episcopal Church (TEC) and any clergy person in good standing in TEC may sponsor a nomination.

2. No self nominations are permitted.
3. No nominations will be accepted after the deadline stipulated in the Nominating Packets.

## **Who can be nominated?**

All Bishops and Priests of “the Anglican Communion...of those duly constituted Dioceses, Provinces, and regional Churches in communion with the See of Canterbury...” (*Preamble of the Constitution of The Episcopal Church, 1*) are eligible.

## **How are nominations made?**

1. A Nominator Packet must be completed as instructed and received by the Standing Committee by 4:00 p.m. (CDT) April 12, 2010. Nominator Packets are to be sent to: The President of the Standing Committee, Episcopal Diocese of Springfield, 821 South Second Street, Springfield, IL 62704.
2. Nominator Packets are available on the website ([www.episcopalspringfield.org](http://www.episcopalspringfield.org)) and hard copies may be requested from the Episcopal Diocese of Springfield, The Election Committee for the XI<sup>th</sup> Bishop of Springfield, The Rev. 3. The Election Committee will then send the Nominee Packet to the proposed Nominee for completion and submittal.
4. ALL materials required for the Nominee Packet must be received by the Standing Committee by 4:00 p.m. (CDT) on May 13, 2010.

## **Will the Election Committee ‘Screen Out’ any Nominees?**

The Standing Committee is responsible for facilitating the in-gathering of information about all nominees and will forward to the Election Committee all information collected on the nominees for processing. The Standing Committee will forward information on all qualified nominees to the Nominating Synod. It is the responsibility of the Nominating Synod to select the final Candidates for the next Bishop of Springfield.
